# **Calculating 2018 Crop Production Costs – What is** your best choice for swing acres?

10 a.m. to Noon Putting sound numbers to 2018 production costs We will analyze all the different inputs and calculate our area's average cost of production for our primary crops, and you will be able to plug your own numbers in to be able to compare. After doing the base budgets, we can analyze different scenarios to see if different management practices may make sense in 2018.

### How much is a ton of corn silage worth this year?

The above question is a fairly common one that we receive in UW-Extension offices in fall and winter. The following is my take on that value for our area.

First, what makes up the value of corn silage? There are many ways that can be looked at and then calculated. The upper end value is the value of milk it can produce, the lower end value is the value of the grain found therein. A relatively common approach is to consider the value of the grain and then add the fertilizer value of the stover that is also being removed. (NOTE: If selling standing corn for silage, this calculated number needs to then have harvest costs subtracted.)

Grain: As grain yield increases per acre, so do the number of bushels of grain equivalent per ton of silage. Growth conditions can also change the number up or down somewhat. For 2017 corn acres, I am using 8 bushels as the average, up from the 7.25 to 7.5 that I usually utilize. This is the number per ton of 65% moisture silage. The question then becomes how much is a bushel worth? Here is one place where you can easily come up with a range, which gives you some negotiation room when completing a sale. 8

B bushels/ton X \$3/bushel (local cash price) = \$24.00	
8 bushels/ton X \$3.50 (CBOT price for Dec. corn)	= \$28.00

Fertilizer equivalents: Data from across the Midwest gives some ranges in the amount of phosphate(P), potash(K), and Sulfur(S) found in the stover portion of corn that is removed in this ton of fresh silage. The UW numbers are somewhere in the middle of the range, so I use those. **Total Fertilizer Value** 

= \$10.52

4.6 lbs P removed per ton X 0.45/lb DAP = 2.07

32 lbs K removed per ton X 0.25/lb potash = 8.00

1 lb S removed per ton X 0.45 / lb elemental sulfur = 0.45

## PRIVATE PESTICIDE APPLICATOR TRAINING

### First Opportunity this season, Last Opportunity with this manual and test Wednesday, December 13 – Pound Town Hall (Coleman – east Cty. Hwy. B)

You have two options to become certified or recertified as a private pesticide applicator. The first is to attend one of the private pesticide applicator training programs conducted by UW-Extension and then satisfactorily complete the evaluation at the end of that session. The second is to study the materials on your own and arrange to take the test in the Marinette office or at some other arranged site. Either method has a \$40 fee which covers the five years of the license.

A minimum score of 50 percent must be achieved on the evaluation administered at the end of the training. **Those choosing the test only option must score 70 percent.** The test is open book and you are allowed 2 hours, with retakes (if necessary) at no extra cost. There will be one or two additional training dates in early 2018, but I scheduled this one to take advantage of finishing off the old manuals and test sheets. It appears that the registration process will be changing January 1, 2018.

The training begins at 10 a.m., with an optional half-hour synopsis of the crop cost of production workshop results starting at 9:30 a.m. Most participants are done around 3p.m.

-Is the Private Applicator Training the right category for me??

If you answer **yes** to any of the questions below, you should become certified in the <u>correct Commercial Pesticide Applicator category</u> call Scott Reuss at the Marinette office, 715-732-7510 to find out the logistics of that process:

- Do you custom spray on more than 500 acres OR for more than 3 other producers?
- Do you custom bale and apply propionic acid on more than 500 baled acres?

- Do you apply restricted-use pesticides to ANY of your own non cropland acreage?

## **Farmland Rental Workshops: Options & Realities**

This annual workshop is designed for both renters and landowners of agricultural land. It is a workshop that I recommend that you try to get owners of rented land to attend. The focus is on land rent realities and options that can make land rental situations better for both parties, and one of the things I emphasize is realities of crop & livestock production economics (I.e. we're not in Iowa, Dorothy).

There are two workshops scheduled that will cover essentially the same information, but with specific discussion according to the interests of those attending.

Thursday, December 7, 6:30 to 8:15 p.m.Pound Town Hall (East edge of Coleman on Cty. Hwy. B)Tuesday, December 12, 10 a.m. to NoonOc. Falls Comm. Library (251 N. Main St., Oc. Falls)Discussion will focus on the details that you should consider when negotiating a farm rental contract. Such details certainly include price, but other factors such as length of lease, any limitations on the property, and many other aspects can all be negotiated into the contract. Many different leasing options are available and Reuss will detail some of the advantages and disadvantages of different annual or multi-year leasing contracts.

Contract templates of multiple types will be available as handouts, ranging from extremely simple to more complex arrangements. The discussion will focus on basic cropland rental situations, but can expand to building leases, grazing land, and other situations which attendees are interested in discussing.

- Also, if you want to sit down with me and discuss planning for 2018 cash rent bids, just let me know and we'll figure out a time to get together. It does not appear to be the right year to let emotions get the best of you and overbid for a parcel. Yes, there are sometimes non-economic reasons to rent land, but do those reasons outweigh essentially guaranteeing a loss because you are paying too much??

# **Dairy Margin Protection Program**

The MPP registration deadline for 2018 coverage is Dec. 15. Refer to the full article in the previous newsletter for complete discussion, but the 5-line synopsis is as such:

- Can opt out of MPP if you want. Simply do not go to the FSA office to sign up. This gives you the opportunity to utilize LGM-Dairy to personalize your farm's dairy margin protection.

- If stay in MPP, must pay the \$100 administrative fee by Dec. 15, and this would be the entire fee if you only want the \$4 basic coverage.

- If increase coverage, premiums increase with coverage, make sure it is right for you.



The colored bands show the middle 50% probability interval for forecast margins. There is a 25% chance that the margin could be above the green band and a 25% chance that the margin could be below the red band. The graph data and probabilities are calculated from futures market data available on 11/10/2017.
