Professional Development Plan - 2016

Every farm should have one.

One of the old adages in business is that if you're not moving forward, you're falling behind. Agriculture changes more dramatically now than it ever has, and we all need to be exposing ourselves and our employees to new ideas and ways of doing things. It may be straightforward concepts such as researching different deep tillage implements to make a purchase decision or trickier things such as gaining understanding of how to transfer the farm from one generation to another. Often, the hardest part is seeing what you need.

What is on your list for 2016?

Every farm will have different priorities, based on their ownership status, employee experience and ability, management challenges faced in previous years, and dozens of other factors. Larger farms will have one list for owners, one for managers, and one for employees. This will be especially true for any farm for which OSHA requirements come into play.

The first step is identifying your topics, then you need to find out what opportunities you have to gain information on those topics. Various entities sponsor seminars, workshops, courses, etc... that can help you meet your goals. Professional organizations are a great place to either attend opportunities or look for ideas: Dairy Business Association, Professional Dairy Producers' of WI, Dairy Calf & Heifer Growers' Association, WI Fruit & Vegetable Growers', and there are all types of individual species or breed associations, as well.

Co-ops, suppliers, and educational & financial entities may sponsor worthwhile events that can either be stand-alone pieces, or help you get started in the right direction. Often, these are low-cost opportunities, but may or may not be as individualized as your operation may need.

How can UW-Extension assist you?

We offer local, regional, and state-wide opportunities, some of which you see elsewhere in this newsletter. We try to find and list all types of opportunities in this newsletter, so watch the events calendar and the pages of the newsletter. We listen to your input for local workshops, so get us your ideas, or offer to host an on-farm training for a particular topic that is of importance.

Also, we can help you on an individual basis. What can this look like? It could be helping set up and facilitate a farm management team. It could be offering skid steer safety training for your employees, or other types of necessary training topics. It can certainly be helping to analyze your operation and find areas to work through, such as protocol development; risk management; employee management; and lots of other possibilities.

Farmland Rental Options Workshops

This annual workshop is designed for both renters and landowners of agricultural land. It is a workshop that I recommend that you try to get owners of rented land to attend. The focus is on land rent realities and options that can make land rental situations better for both parties, and one of the things I emphasize is realities of crop production economics (I.e. we're not in Iowa, Dorothy).

There are two workshops scheduled that will cover essentially the same information, but with specific discussion according to the interests of those attending.

Chase Town Hall (8481 Cty. Hwy. S, Sobieski)

Thursday, December 3, 6:30 to 8:30 p.m.

Pound Town Hall (East edge of Coleman on Cty. Hwy. B)

Discussion will focus on the details that you should consider when negotiating a farm rental contract. Such details certainly include price, but other factors such as length of lease, any limitations on the property, and many other aspects can all be negotiated into the contract. Many different leasing options are available and Reuss will detail some of the advantages and disadvantages of different annual or multi-year leasing contracts.

Contract templates of multiple types will be available as handouts, ranging from extremely simple to more complex arrangements. The discussion will focus on basic cropland rental situations, but can expand to building leases, grazing land, and other situations which attendees are interested in discussing.
