# Mid and Early Career Producer and Agribusiness Professionals

#### Crop & Nutrient Costs Focus of Discussion on February 28

Managing costs of crop production is a challenge every year. 2018 is definitely projected to be a year when getting a positive return on input investment needs to be analyzed for each input type. The Mid & Early Career Producer/Agribusiness Professionals of Oconto, Shawano, and Marinette Counties are hosting a discussion specifically designed to help local producers work through their decision making on some of these crop inputs.

The event is being held at <u>S & S Hometown (211 South Maple Avenue; Oconto Falls), starting at 12:30 p.m. on</u> Wednesday, February 28th. The planned focus of discussion will be on fertilizer inputs, maximizing on-farm nutrient resource returns, and getting the most out of other crop inputs. Attendees will steer the discussion to the topics of their choosing and may include all types of different agronomic inputs, from seed selection and planting rate to pest management decision making. The discussion will be facilitated by Nutrient and Pest Management Outreach Specialist Jamie Patton and Marinette/Oconto County UW-Extension Crops Agent Scott Reuss.

Interacting with other producers whom are also making critical input decisions is a great way to assist in your farm's analysis processes. This group was formed by producers in the three counties to help provide discussion opportunities that lead to improved profitability for all farms involved. ## What impact has the Veterinary Feed Directive had on you & your herd?

Managing the health of your herd is a primary responsibility of all farmers. The Veterinary Feed Directive (VFD) rules that went into effect January 1, 2017 may have impacted how you manage herd health. The rules limited the use of medically important antibiotics to disease prevention, control or treatment, and only when a veterinarian writes a VFD for their use.

How have those rules affected your management as well as the health of your animals? Michigan State University Extension, in partnership with Land-Grant Universities nationwide, is conducting a survey of farmers who raise and manage dairy or beef cattle, pigs, sheep or goats. They want to learn about changes that have occurred, in response to the VFD, in terms of your use of antibiotics, health of your herd, and in your relationship with your veterinarian.

The survey is open from now until April. All responses are confidential and your participation is voluntary. It should take 10-15 minutes to complete. Your thoughtful answers, with examples, will provide information which will be used to design educational programs that help food-animal producers.

This survey is only for farmers over the age of 18 who raise food-animals impacted by the VFD rules. Farmers in every state are invited to respond to the survey. Key questions to be answered are what the impacts of any changes have been on health management of herds and on herd performance.

## County Deer Advisory Councils to hold meetings in March and April

Each county in the state of Wisconsin has a County Deer Advisory Council. They will each be meeting this spring in a pair of meetings, with a comment period in between. The first meetings will be held in March and have the primary purpose of reviewing data and forming preliminary 2018 antlerless quota, permit and season structure recommendations. Oconto County's CDAC will meet on Tuesday, March 20<sup>th</sup> at the Gillett Community Center (204 E Main St.) from 7 – 9 p.m. The Marinette County meeting will be held at the Crivitz Village Hall (800 Henriette Avenue, Crivitz WI 54114) on Wednesday, March 21st starting at 6pm.

While this is a working meeting of the council, the public is encouraged to attend and will have a formal opportunity to provide insight during the public comment period of the meeting. Local Department of Natural Resources staff will be on hand to present information and answer any questions. CDACs are part of an effort to provide more public input on deer management issues and give stakeholders a greater responsibility in managing local deer numbers.

Following the March meetings, an online public comment period will take place from April 2-12, with final council meetings being held between April 16 and 19. This meeting for Marinette County's CDAC will be held on Wednesday, April 18<sup>th</sup> (also starting at 6 p.m. in the Crivitz Village Hall). The council will review public feedback before making final recommendations on the antlerless quota, permit and season structure. Recommendations will be sent to the Natural Resources Board for approval in May.

Some county councils have vacant seats and qualified individuals are encouraged to look at the list of members if interested in being a member of this council. #### Youth for the Quality Care of Animals (YQCA)—formerly Meat Animal Quality Assurance Training

The YQCA training will provide a common framework for food animal quality assurance programs which will strengthen the youth educational experience, improve the care of food animals, and promote a higher level of consumer food safety. Youth will also learn about other species of animals; not just the species they show.

The YQCA program is supported by Wisconsin 4-H and FFA leaders. Youth for the Quality Care of Animals training content and modules will demonstrate a progression of topic knowledge in designated age categories (age as of January 1): •Junior (8-11 years old) •Intermediate (12-14 years old) •Senior (15-18 years old) •Young Adult (19-21years old).

The new format is an effort to provide flexibility to accommodate busy seasonal schedules while providing relevant age-specific food animal quality assurance training. Youth exhibitors will complete three interactive online modules and quizzes which can be accessed according to your schedule. In Wisconsin, face-to-face trainings may be offered in specific counties for juniors (8-11 year olds) <u>only</u>. On average, it will take 60 minutes per year to complete all the required online training modules or in-person training—depending on age.

Youth completing the online modules will pay \$12/person/year, and face-to-face trainings offered for juniors (youth age 8-11) will pay \$3/person/year.

To complete the YQCA online training or register for face-to-face training, log into <a href="http://yqca.org">http://yqca.org</a>. Follow the step-by-step instructions to create a user identity and password. All payments for either online or inperson training will be made using the YQCA website. Additional material fees (beyond the \$3.00 payment to YQCA) for in-person training may apply, and if so will be collected at the time of the face-to-face training.

Two in-person trainings will be offered for juniors (8-11 year olds ONLY). The dates and locations of the trainings are listed below. Space will be limited, and registration will be taken only through the YQCA website (http://yqca.org).

## State Fair Dairy Promotion Board Scholarships Available

The Wisconsin State Fair Dairy Promotion Board is offering \$1,000 scholarships to be used during the second semester of the 2018-19 school year. Third and fourth-year college students pursuing dairy-related or food science degrees at one of Wisconsin's four-year universities are eligible to apply.

Additional scholarships will be available to high school seniors planning to pursue a dairy-related or food science degree at one of Wisconsin's four-year universities or students studying in a two-year, technical school program related to dairy or food science. Applicants will be evaluated on involvement and leadership in dairy-related activities, scholastic achievement, and career objectives. Finalists will be interviewed in mid-April, with recipients to be recognized at the 2018 WI State Fair.

# Dairy Margin Protection Program Changes – Watch for Sign-up Period!

In a relatively unusual move, the federal legislature passed a significant set of changes to the Dairy Margin Protection Program as part of one of the recent continuing spending resolution bills. The bill was signed by President Trump and the changes are summarized below. The changes are relatively advantageous for most dairy producers, as they increase Tier 1 coverage to 5 million pounds of production and change the Tier 1 premiums to producers' favor.

The table copied below is part of a larger document on these changes found at <a href="https://dairymarkets.org/PubPod/Pubs/BP18-01.pdf">https://dairymarkets.org/PubPod/Pubs/BP18-01.pdf</a> You can go to the Dairy Markets and Policy web page main page (University of Wisconsin's Dairy Marketing program) and then navigate to it, as well. As you can see, the buy-up coverage now starts at \$5.50 margin protection, rather than \$4.50, meaning that all producers get \$5 coverage for only the \$100 administrative fee on their first 5 mil. Lbs. They have also really lessened the premiums in Tier 1, making it very likely that you can receive your premiums back due to margins being lower than the \$8 level. The other major change is that the margin payments will be made on a monthly, rather than pair of months, basis. This also increases likelihood of indemnity payments.
