## **TEEN COURT**

Cases are presented in the Oconto County Courthouse or other Governmental building in front of the Teen Panel. Everyone in the courtroom takes an oath of confidentiality. The offender is sworn in and questioned by the teen panel to determine the circumstances of the offense. After carefully listening to the facts, the teen panel leaves the courtroom to discuss a constructive sentence for the defendant. Examples of sentences could include letters of apology, community service, essays, projects, counseling or workshops.

### To participate in **Teen Court** you must admit your guilt in the Court System and meet the following requirements:

**1**• You must be between the ages of 10 and 17

and have committed a misdemeanor crime or ordinance violation such as:

- " Retail theft or shoplifting
- " Disorderly conduct
- " Underage drinking or tobacco use
- " Receiving or concealing stolen property
- " Trespassing
- " Criminal damage to property/ vandalism
- " Obstructing
- " Truancy
- " Drug paraphernalia
- " Loitering/curfew
- " Battery
- " Marijuana

**2.** You must be referred to Teen Court.

**3.** You must admit to committing the offense you have been charged with. You must also be willing to participate in Teen Court and be willing to follow its rules.

**4**• You must have a parent/guardian who is willing to accompany you to Teen Court.

**5**• Pay the \$25 court fee (To UW-Extension) collected during Teen Court.
